In accordance with the Finance law N° 2022/020 of 27th December 2022 of the Republic of Cameroon for the 2023 fiscal year,

I have the honour to inform you that the modalities for the collection, preservation and management of Registration fees for official Examinations for the session 2023 have been modified as follows:

The process of acquiring the fiscal stamp shall be by TELE DECLARATION and payment made through the Bank or Mobile money. This shall be ensured by the Chief of Bureau of General Affairs at the Sub Divisional Inspectorate of Basic Education. The receipt of payment for the fiscal stamp shall be forwarded to the Divisional and Regional Delegations alongside the other finances stipulated in the previous circular.

The 100 FRS for Tele Declaration per candidate and per exam shall be used for bank/mobile money transfer charges and the buying of office material (ink, paper etc) for the tele declaration process.

The rest of the Articles/provisions of the previous circular remain unchanged.

I invite you to strictly respect the disposition of this present circular.
